# UltraTech Q1 Net Up 49% on Higher Sales, Meets D-Street Estimates

Co to review merger of India Cements after cleaning up operations for a turnaround: CFO

Mumbai: UltraTech Cement may take a call on whether or not to merge India Cements with it by 2027 or 2028, chief financial officer Atul Daga said. "First and foremost, it's very important for us to clean up the India Cements' operations, bring it up to speed, which is a turnaround of the company, align people, processes, product, and then we will take a call on whether to merge or not to merge," Daga said on Monday. India Cements became a subsidiary of UltraTech in late December last year. "We are fully cognisant of a huge amount of stamp duty that would be involved. Why spend money on that? But if it's worthwhile, perhaps in (2027 or 28, actually, we will revisit the decision," Daga told analysts on a call after the company's quarterly earnings. India Cements achieved a breakeven in terms of earnings before interest, tax, depreciation and amortisation (Ebitda) by March. In April, UltraTech's management said the subsidiary's Ebitda per tonne would hit ₹500 in the current fiscal 2026, ₹600 in fiscal 2027 and ₹1,000 in the following fiscal year. It made ₹400 per tonne of Ebitda in the quarter ended June 30, after taking into account the limestone royalty of ₹160 per tonne in Tamil Nadu. At a consolidated level, India Cements made a loss of ₹132.9 crore for the June quarter compared with a profit of ₹58.4 crore a year earlier, weighed by an exceptional loss of ₹123.7 crore due largely to impairment charges. Given that cement prices have been favourable, India Cements could achieve Ebitda per tonne of ₹1,000 before fiscal 2028, Daga said. "Prices holding up obviously could help us achieve our targets earlier. Besides prices, most important is the integration effort," he said.

13% RISE IN CONSOLIDATED SALES TO ₹21,040 CRORE

UltraTech posted a consolidated net profit of ₹2,226 crore in the first quarter, up 49% on year and in line with market estimates. Its numbers for the quarter include those of Kesoram Industries and India Cements, both of which were not a part of the company a year earlier. While India Cements is independently listed and announced its quarterly earnings last week, the numbers for Kesoram were not separately available. Consolidated sales increased 13% on year to ₹21,040 crore, while sales volume rose 9.7% to 36.83 million tonnes. Profit before interest, depreciation and tax was ₹4,591 crore, up 44% from a year earlier.

# Havells India Profit Falls 14%

Kolkata: Cables and air-conditioner manufacturer Havells India on Monday announced a 14% year-on-year (yoy) drop in its standalone net profit at ₹352 crore for the first quarter ending June, with net sales taking a hit by 6% year-on-year at ₹5,438 crore due to a weak summer which impacted sales of the company's air-conditioners, fans and air-coolers. The company's chairman and managing director Anil Rai Gupta told analysts in its quarterly earnings call there is high channel inventory for ACs which will take 1-2 quarters to liquidate and the company is accordingly adjusting production. The company's refrigerators and AC business declined by 34% yoy in the quarter under review. "The first quarter was a challenging one with unexpected weak summer impacting overall performance, however we feel this is transitory and expect revenue growth and margin improvements over ensuing quarters," he said.



# DLF Settles Row with Hubtown, Exits ₹10k-cr Mumbai Project

Mumbai: Realty developers Hubtown and DLF have settled their long-running dispute over one of south Mumbai's most high-profile redevelopment projects, spread over 17 acres and valued at over ₹10,000 crore, through consent terms including ₹800 crore payment to the latter, said people with direct knowledge of the development. As part of this arrangement, DLF has exited the Tulsiwadi urban renewal project next to the Willingdon Club in Tardeo, bringing an end to years of litigation and clearing the way for the project to move forward. DLF has formally withdrawn all its litigations against Hubtown, Twenty-Five Downtown Realty (formerly Joyous Housing), PNB Housing Finance and others under these consent terms agreed upon last week. In return, Twenty-Five Downtown, an entity affiliated with

Hubtown, will pay DLF ₹800 crore over the next two years. As part of the agreement, ₹100 crore has already been paid as the first tranche. Hubtown has mortgaged 150,000 sq ft of space in the proposed project in favour of DLF as security for the balance payment of ₹700 crore, documents registered last week show. ET has reviewed the indenture of mortgage. DLF had announced the arrangement in an earlier filing but did not specify the total settlement amount. DLF and Shapoorji Pallonji Group's Chinsha Properties held 37.5% stake each in the SPV formed to redevelop the Tulsiwadi slum cluster alongside Hubtown's 25%. The project ran into financial and legal issues after a ₹900-crore loan from PNB Housing Finance turned non-performing in 2021. After the default, PNB Housing Finance invoked pledge shares of Chinsha and DLF, selling them to recover its exposure. The loan was taken over by Omkara Asset Reconstruction Company. The share transfer and pledge invocation triggered allegations from original shareholders, especially DLF, over wrongful ouster and shareholder rights violations. A DLF spokesperson confirmed the settlement while ET email query to Hubtown remained unanswered.

# EU Set to Counter as US Tariff Deal Prospects Dim

Brussels: The European Union is exploring a broader set of possible counter-measures against the United States as prospects for an acceptable trade agreement with Washington fade, according to EU diplomats. An increasing number of EU members, including Germany, are now considering using wide-ranging "anti-coercion" measures which would let the bloc target US services and other sectors in the absence of a deal, diplomats say. The European Commission, which negotiates trade agreements on behalf of the 27-member bloc, had appeared on course for an agreement in which the EU would still have faced a 10% US tariff on most of its exports, with some concessions. Such hopes now seem dashed after President Donald Trump's threat to impose a 30% tariff by August 1, and following talks between EU Trade Commissioner Maros Sefcovic and US counterparts in Washington last week. Sefcovic, who has said a 30% tariff would "practically prohibit" transatlantic trade, delivered a sober report on the current state of play to EU envoys on Friday, diplomats told Reuters.



US counterparts had come up with diverging solutions during his meetings, including a baseline rate that could be well above 10%, the EU diplomats added. "Each interlocutor seemed to have different ideas. No one can tell (Sefcovic) what would actually fly with Trump," one diplomat said. Prospects of easing or removing 50% US tariffs on steel and aluminium and 25% on cars and car parts appear limited.

**'NUCLEAR OPTION'** Washington has also rejected the EU's demand for a "standstill" arrangement, whereby no further tariffs would be imposed after a deal is struck. The rationale, according to diplomats, is that Trump's hands cannot be tied on national security, the basis of Section 232 trade investigations into pharmaceuticals, semiconductors and timber.
